SACK SUPPERS ARE NUTRITIOUS EVENING MEALS DELIVERED WEEKDAYS TO NEARLY 8,800 CHILDREN ACROSS WEST MICHIGAN PRE COVID. EACH MEAL IS PREPARED, PACKED AND DELIVERED WITH THE SUPPORT OF MORE THAN 250 DAILY VOLUNTEERS. VOLUNTEERS PROVIDED MORE THAN 62,600 HOURS OF TIME AND COMMUNITY DONATIONS OF IN-KIND FOOD HELPED US SERVE A TOTAL OF 1,229,524 MEALS IN 4 WEST MICHIGAN COUNTIES.
