VOLUNTEERS PROVIDED MORE THAN 74,000 HOURS OF TIME AND COMMUNITY DONATIONS OF IN-KIND FOOD HELPED US SERVE A TOTAL OF 1,830,000 MEALS IN FOUR WEST MICHIGAN COUNTIES.
