ACCESS IS THE FOUNDATION OF GOOD HEALTH, AND THE FLAGSHIP SACK SUPPER PROGRAM AND WEEKEND MEAL DELIVERY PROVIDED A TOTAL OF 1,874,000 MEALS SERVED (AN AVERAGE OF 11,000 MEALS ARE PREPARED, PACKED, AND DELIVERED EACH SCHOOL DAY ACROSS WEST MICHIGAN). THIS WORK CANNOT BE DONE WITHOUT THE SUPPORT OF DAILY VOLUNTEERS. VOLUNTEERS PROVIDED ALMOST 78,000 HOURS OF TIME IN SUPPORTING THIS WORK.
